## ACCOMMODATIONS

**Effective November 01, 2023:** These rates apply to all new accommodation bookings or extensions for stays after Oct. 31, 2023.

### Placement fee (non-refundable): \$300

- > 1 week = 7 nights.
- > Must book a minimum of four (4) weeks before arrival.
- > Must arrive and depart on a Saturday or a Sunday.
- > Single person bookings not accepted for double rooms.

### Homestay Deposit Policy:

- > Payment of first four weeks and submission of flight info required to receive Homestay details.  
For bookings of fewer than 4 weeks, full payment of homestay fees required to receive homestay details.
- > Homestay Payment required 60 days in advance of arrival to guarantee placement.

### IMPORTANT NOTE - Effective November 01, 2023:

## TUITION REFUND POLICY - GV VICTORIA

- Should a student visa be rejected by IRCC, the rejection letter should be submitted to the school.
- On receipt of the official visa rejection letter, the school will retain the nonrefundable registration fee and any nonrefundable accommodation fees. All other tuition and fees will be refunded.
- The school's waiver of the nonrefundable registration fee due to a promotion or a returning student shall be invalidated in case of the student's visa denial or booking cancellation, and the school shall retain this fee.

*In this policy, the word "program" refers to the full cycle of studies to which the student registered. All refunds apply based on the assumption that the full payment has been received.*

### PROGRAMS OF LESS THAN 6 MONTHS AND LESS THAN \$4000 TUITION:

#### 1. Effective before the start date

- 1a.** If a student cancels 30 days or more before the start of the program, the school will retain 25% of the fees due under the contract and refund 75% of the fees to the student.
- 1b.** If a student cancels less than 30 days before the start of the program, the school will retain 40% of the fees due under the contract and refund 60% of the fees to the student.

#### 2. Effective after the start date

- 2a.** If a student cancels (or is dismissed) within 5 calendar days of the start date of the program, the school will return 50% of all unused tuition fees paid under the contract.
- 2b.** No refund will be paid if a student cancels (or is dismissed) when more than 5 days of the program have been completed.
- 2c.** Refunds on postponed starting dates are based on the original start dates (applies also to students transferring from one GV school to another).
- 2d.** The school will refund the materials & technology fee paid for any instructional weeks not provided to the student, regardless of what percentage of instruction is completed.

### PROGRAMS OF MORE THAN 6 MONTHS OR MORE THAN \$4000 TUITION:

A student may be entitled to a refund of tuition fees in the event that:

- The student provides notice to the school that he or she is withdrawing from the program; or
- The student provides a copy of the visa rejection letter from Canadian Embassy
- The school provides notice to the student advising that the student has been dismissed from the program.

1. The notice of withdrawal or dismissal may be delivered in any manner provided that a receipt or other verification is available that indicates the date on which the notice is delivered.
2. The notice of withdrawal or dismissal is deemed to be effective from the date it is delivered.
3. The refund to which a student is entitled is calculated on the total tuition fees due under the contract. Where total tuition fees have not yet been collected, the school is not responsible for refunding more than has been collected to date and a student may be required to make up for monies due under the contract.
4. If the school has received fees in excess of the amount it is entitled to under the student contract, the excess amount must be refunded.
5. Refund policy for students before the program of study starts:
  - 5.a** If notice of withdrawal is received by the school 30 days or more before the commencement of the period of instruction specified in the contract and more than 7 days after the contract was made, the school may retain 10% of total tuition only due under the contract to a maximum of \$1000.
  - 5.b** Subject to Section 6(a)(1) above, if notice of withdrawal is received by the school less than 30 days before the commencement of the period of instruction specified in the contract, and more than 7 days after the contract was made, the school may retain 20% of the total tuition only, due under the contract to a maximum of \$1300.
6. Refund policy for students after the program of study starts:
  - 6.a** If notice of withdrawal is received by the school or a student is dismissed before 10% of the period of instruction specified in the contract has elapsed, the school may retain 30% of the tuition due under the contract.
  - 6.b** If notice of withdrawal is received by the school, or a student is dismissed after 10% and before 30% of the period of instruction specified in the contract has elapsed, the school may retain 50% of the tuition due under the contract.
  - 6.c** The school will refund the materials & technology fee paid for any instructional weeks not provided to the student, regardless of what percentage of instruction is completed.
7. Where a student did not meet the school's specific minimum requirements for admission through no misrepresentation or fault of their own, the school must refund all tuition and fees paid under the contract, less the nonrefundable registration fee.
8. Refunds owed to students must be paid within 30 days of the school receiving notification of withdrawal and all required supporting documentation, or within 30 days of a school's notice of dismissal.

*\* This policy has been approved by the Private Training Institutions Branch (PTIB) of the Ministry of Post-Secondary Education and Future Skills and is compliant with the Private Training Act. See the dispute resolution policy for further details.*

  - 3.a** The student should inform the GV Homestay Office four weeks before the end of the homestay period if he/she decides to terminate the agreed homestay period. If the notification period is less than 4 weeks, then in addition to the non-refundable notification period, a \$150 cancellation fee will apply.
  - 3.b** If the host family has failed to meet the Homestay conditions, the student will be moved to another Homestay, and there will be no refund given for the period of homestay already used.
